The contractor should have necessary documents in support of qualification according to PPR 2008 (Latest Amendment) Rule 49 and tender document (PW-2A), and the rules and regulations under the cantonment account code of 1955 will be followed.</p> <p>c. The tender participant will have to submit the tender security in favor of cantonment board, jahanabad cantonment through bank draft/pay order from any scheduled bank.</p> <p>d. The amount of work may be more or less per the decision of the authority, the bill will be paid on the basis of measurement.</p> <p>e. The price of each item should be mentioned in the figure and the total amount should be mentioned in figures and in words.</p> <p>f. Other information of the tender can be known from the Cantonment Board during office hours.</p> <p>g. VAT and income tax will be deducted as per government rules.</p> <p>h. After the completion of the work, the bill will be paid on the basis of examination.</p> <p>i. The authority reserves the power to accept or reject any or all tender without showing any reason.</p>
